I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Vaughan Sportsplex II, Sportsplex II, Vaughan Sportsplex Inc, Sportsplex Ltd, Vaughan Sportsplex 2 and GTA Sportsplex Limited & their directors, officers, employees, agents and representatives (all of whom are hereinafter collectively referred to as "Vaughan Sportsplex") and to waive any and all claims, demands, or causes of action, that I have or may have in the future against, Vaughan Sportsplex and to release, Vaughan Sportsplex from any and all liability for any loss, damage, expense or injury including death that I may suffer or that my family, heirs, assigns, personal representatives and estate may suffer as a result of my participating in Vaughan Sportsplex sports, trampoline, rock climbing, rope climbing and warp wall games or activities DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS' LIABILITY ACT, R.S.O. 1990, c. O. 2 ON THE PART OF VAUGHAN SPORTSPLEX AND FURTHER INCLUDING THE FAILURE ON THE PART OF VAUGHAN SPORTSPLEX TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF VAUGHAN SPORTSPLEX, TRAMPOLINE, ROCK CLIMBING, ROPE CLIMBING AND WRAP WALL TRAMPOLINE GAMES OR ACTIVITIES (HEREINAFTER REFERRED TO AS "CLAIMS"). This Agreement shall be governed by and interpreted in accordance with the laws of the Province of Ontario and any litigation involving the parties to this Agreement shall be brought within Ontario.
